

# Abortions Remain Legal in New York State

**New York will continue to make abortion care accessible to everyone—including undocumented immigrants and visitors from out of state.**



## What you need to know

- Roe v. Wade was overturned by the Supreme Court on June 24, 2022. The legality of abortion is now under individual states' decisions.
- However, abortion remains legal in New York State, and is accessible to everyone including undocumented immigrants and visitors from out of state.
- Under New York State law, health care practitioners may provide abortion care up to and including the second trimester (24 weeks), and after that point in cases where a patient's health is at risk or if the pregnancy will not survive.
- Abortion services in New York State are completely confidential.

# How to navigate reproductive health services

## New York State residents

In New York State, health insurance, including Medicaid, may cover the cost of an abortion.

Abortions are a covered benefit in New York.

- Enroll in a health insurance plan through the NY State of Health exchange: [nystateofhealth.ny.gov](https://nystateofhealth.ny.gov)
- For New Yorkers who need help with payment, there are resources available that can help cover costs. Health insurance options from New York State: [health.ny.gov/health\\_care/managed\\_care/paying](https://health.ny.gov/health_care/managed_care/paying)

For New York City residents: abortions are covered under NYC Care, a healthcare access program for low-income residents who are excluded from Medicaid.

- There is no residency requirement to sign up for NYC Care so eligible applicants can access healthcare as soon as they have a proof of a New York City address.
- Undocumented immigrants can receive low-cost to no-cost healthcare services (including abortions) at NYC Health and Hospital locations: [www.nychealthandhospitals.org/abortion](https://www.nychealthandhospitals.org/abortion)
- You will not be asked about your immigration status when seeking care.

## Visitors from out of state

New York State coverage requirements for abortion services only apply to policies purchased in New York State.

- Visitors from out of state may not have abortion coverage if they or their employer purchased a health insurance policy in a state that restricts abortions.
- Check your insurance policy to determine if you have coverage for abortion services.
- Your employer may also cover travel costs associated with receiving an abortion. Talk to your employer about options they may have to help.

## Confidentiality

- Abortion services in New York must be completely confidential.
- Abortion providers and other healthcare professionals are not allowed to disclose any information to anyone other than you, without your permission.
- This includes your medical records, as well as any information about your appointment or procedure.
- This means that no one will receive information about your abortion without your express permission, including: the other biological parent of the fetus, your parents (if you are a minor), and anyone else who you have not identified as having your permission to receive information about your abortion.
